### TAKING STOCK

- At stock-taking, all belt data is entered into the AMMcare management system of Ammeraal Beltech. Conveyor installations are then marked in a unique manner in accordance with codes specified by you. This marking is done by means of stickers or embossed plastic plates fitted to each separate conveyor installation.
- In addition, we can periodically inspect your conveyor belts. At each inspection an assessment can be made of important criteria, including those listed below.
- Is the choice of belt correct and which belt would be the most appropriate for the future?
- Is the condition of the belt acceptable and is the belt tension correct with a view to achieving optimum product life?
- Are the position and lining of the drums still in order?
- Are components such as support rollers, scrapers, gaskets and bearings still functioning correctly?
- Is stock control still up to date?


